shall as soon as conveniently may be after my Decease sell and
dispose of all my Goods and Chattles which I shall dye possessed
of and all the Securities for moneys which I shall leave at my
Decease and my Will and Meaning is that the Mortgage which
I now have on the House of John Aunraster of Aunraster in the
County of Surry Yeoman shall immediately be delivered in to
the said John Aunraster after my Decease and all the principall
and Interest discharged and the said John Aunraster freed
therefrom and my further Will and Meaning is that my
Executor hereafter named shall out of the moneys arising by
Sale of my Goods and Chattles and the debts and Credits due
to me shall pay the sum of Twenty pounds (that is to say)
the sum of Ten pounds apiece to Mary Sayres and Elizabeth

my Intent and Meaning that they shall respectively receive the

twenty years or day of Marriage then the Legacy of her so dying
shall remain and be paid to the Survivor of them and if both my
